




Financial Transfers

Looking deeper into the top 2

Macroeconomics

Tax code

Allocated 1% of fines from illegal use of the public maritime domain to coastal management.

Extended the deadline to file and pay income tax.

Required VAT on all foreign-currency transactions to be calculated in Lebanese pounds at the central bank's effective exchange rate.

Changed the fees collected by the Chamber of Commerce, Industry, and Agriculture in Zahle and the Bekaa.

Determined the conditions for **importing** live livestock.

Mandated companies that export artifical beverages to EU countries that prohibits the use of titanium dioxide (E171) to ensure their products are free of this substance.

Legal Window of 15 Days

Regulated trade in wild species of animals and plants.

Ended the service of Sheikh Abdul Rahman El-Mohammadi Mashaieh in the name of the Sunni Sharia Courts upon rehiring the legal services and conditions set by the International Arbitration Center (IAC) or by the National Arbitration Center (NAC).

Licensed the establishment and cancellation of the private higher technical institution named Afaq Institute for Technology.

Canceled letter No. (127-1-2024) dated 20-10-2024 and all its legal effects, which concerned defining the requirements for the sport of table tennis.

Defined the names of pilot practitioners (sofa and conditions) set by the International Air Sports Federation (FAI) or by the National Federations/Associations recognized by the FAI.

Authorized the International Food and Beverage Company S.A.L. to bottle drinking/table water and soft drinks.
